An account is given of the relevant activities of various European-level civil society groups including the European Disability Forum, the European Coalition for Community Living, and the Mental Disability Advocacy Group. The Yearbook also contains a bibliography of major publications in the field of European disability law and policy, as well as an annex containing the full text of the most significant documents and policy developments.
